#### 2004 BACKCOUNTRY HORSEMEN OF MONTANA CONVENTION

#### Pre Convention Meeting March 19<sup>th</sup> 2004

Minutes from December meeting were approved as written. Bill Maloit complained that a discussion item he raised was not in the minutes. Carellen Smith the secretary said the minutes were an abbreviated form of the meeting and not all discussion items are recorded only items that action was taken on.

Kathy Allard, the treasurer handed out a detailed balance sheet and reported we had \$5047.84 in the account on December 6<sup>th</sup> 2003 and on March 19<sup>th</sup> we had a balance of \$8963.10. Kathy noted that the BCHMT silver buckles had gone up considerably from the last time they were purchased and noted that they did not look as good. They now cost about \$154 each and we are selling them for \$125. A motion to sell all seven buckles for \$160 to get rid of them was passed.

The National Directors reported that the Right to Ride legislation needs 150 co-sponsors to pass. Chuck Miller said they are looking at putting together a folder of all of the BCH state chapters and wanted each of the delegates to give him a 1-1.5 page summary of club activities along with a photo. Chuck also requested a summary of the BCHMT web site. Chuck also said each club should apply for 501 – C4 status by registering with the state through Bob Brown at sos@state.mt.us, 444-3665 by March 31<sup>st</sup>. The chapters then need to send in an application with Peg Grievy of the BCH of America organization.

Smoke Elser described the work that is being done regarding the horse safety requirement for Forest Service volunteers. Smoke along with Ron Stuber and John Favro have a document ready for signature of the regional forester essentially allowing the BCH to provide a list of trainers to the FS to teach the horse safety course. A manual was created by Ron Stuber to act as a guide for the training. This action was pursued to hopefully prevent having a less qualified FS employee attempt to train members of the BCH in horse safety. Smoke seemed to think that the regional forester was going to sign it within a week.

Steve Didier the Chairman of BCH of America gave a talk on issues facing the organization. He said even though we come from diverse backgrounds we are more similar than different. He asked for help in adding to the legislative fund to protect our rights for horse use in the back country.

There was a handout for helping apply for trail grants. Everyone was told to keep an eye on the Forest Service Travel Plans in their area and report back to the committee with any information that would be of use to the organization. A handout of the current constitution was distributed and any changes should be submitted to the Constitution Change committee. A resolution was passed to hold a silent auction at each convention with chapters encouraged to bring an item of around \$50 or greater in value.

A special agenda item was brought to the floor in the form of a resolution from the Flathead chapter concerning drilling on the Rocky Mountain Front. The reason given for the late entry was last minute information that demanded immediate action. Dave Schilz pointed out that the item must be presented to the Chairman prior to the meeting and it must be voted on as a bona fide item. Since Dave did not receive notice of it prior to the meeting it is against the constitution to vote on it. The board voted 20 to 10 to go against the constitution and enter the item as a special agenda item to be voted on at the convention.

The topic of insurance was brought up and a web page will be set up with insurance contacts displayed for chapters to investigate. The question of who was covered was discussed asking whether both participants and spectators were covered.

#### Convention March 19<sup>th</sup> & 20<sup>th</sup> 2004

National Anthem was performed by Mary Allen who did a marvelous job. UMW Chancellor Karl Ulrich spoke on the roots of the college in equestrian education. Jim Chambers who is 95 years young gave a short speech on what it means to be a Back Country Horsemen. It was announced that the photo competition had over a hundred entries. A slide show of the Three Rivers area was presented by Dan & Lois Pence.

The eight resolutions were voted on with a lot of discussion on each item. A brief summary of the resolutions include:

- 1. Raise dues to BCHM \$5.00 to cover cost of BCHA dues increase. Passed
- 2. Raise dues to \$5.00 for BCHA. Passed
- 3. Dual membership quidelines. Passed
- 4. BCH & FS Signage. Failed
- 5. Liability waiver for horses. Failed
- 6. Training provided for certification. Lots of mods. Failed
- 7. Travel Plan position statement. Lots of mods. Passed
- 8. Special Agenda Rocky Mountain Front drilling. Passed



Bob Walker gave talk on submitting trail grants to FS. You have to fill out all of the questions to get accepted. They are willing to help. Contact him at <a href="mailto:bwalker@state.mt.us">bwalker@state.mt.us</a>, 444-4584 or Steve Gilbert 444-7642. Jim Jones a member of the Trail Committee is moving to Big Sky 252-3800. Kurt Dyer is on committee and has done a lot to help BCH move up in the point structure.

Lobby had a live rattle snake presentation. Snake handler distributed new first aid instructions for snake bite. Vendors had lots of goodies to eat. Saddle Maker demonstrated putting leather on a tree. Someone displayed horseshoeing with plastic shoes that are supposed to be easier on the hoofs.

#### Post Convention March 20th 2004

New officers were elected. No new nominations from the floor. Dave Crawford – Chairman, Ron Stuber – Vice Chairman, Charley O'Leary – Treasurer, and Kathy Frazier was appointed Secretary. Standing Committee Chairman were established including Kurt Dyer – Issues, Jason Newton – Education, Bill Maloit – Expansion, Chuck Miller – Membership, Linda Brewer – Newsletter, Dan Marsh – Web Site. Working Committee Chairman include Bob Facklam – Convention, Smoke Elser – Horse Safety Training, Mike Chandler – Forest Travel Plan, Ken Ausk – Constitution Revision, Julie Schram – Live Auction. It was agreed that Kathy would contact the people that sold us the Belt Buckles and implement the clause that states if you are unhappy with the quality return them for a full refund. We need an inventory of BCHMT assets. East Slope will host the 2005 convention. The 2006 host will be determined at the May board meeting. The dates and locations were set for the 2004 board meetings including May 1<sup>st</sup> in Great Falls, September 11<sup>th</sup> in Deer Lodge, December 11<sup>th</sup> in Missoula. Smoke said we should establish a Liason committee for speaking to public organizations so we don't ruffle any feathers. Smoke was nominated as the Chairman. There will be a FS meeting in Augusta on May 10<sup>th</sup> with a few BCH members. The audit of the treasurer report was found to be accurate. There is a meeting of the LAC on April 17<sup>th</sup> in Choteau and Rich Fitzpatrick will be in attendance.

LIGHT ON THE LAND Program for members was presented by Harry . His topic was an alternative to building a traditional fire. Things to consider are site selection, equipment to mitigate heat and ash to the ground, selection of fuel to eliminate escape of embers. Picking bare ground is best, if none, spade a circle of sod with the soil & save to a shady spot and water to replace when done. Place a piece of fire blanket on the ground. Set small stones/gravel on the blanket. On this another fire blanket piece is set, here make a pile of charcoal briqs to ignite. Harry likes to use a Dutch oven for cooking and places a number of the hot coals on the lid. A third piece of fire blanket set on top with the reflective surface down holds in heat and if it is windy holds in the embers if not using charcoal. Thanks Harry & Alice for all your support and contributions to the club.
