
Bonnie says, "Thank you all, my knee surgery was a great success."

# Will these trail crew reports end soon? By Chick Hale

I thought last month's report would be the last, but odds and ends are still being completed. On October 21st Wally and I spent a total of ten hours working on our "Becker-Hale" portion of the #401 trail. Spring and fall we try to get all twenty-six water bars cleaned and working properly. We also removed some rocks and leveled short sections of trail. For those who were-



n't around back then, Wally with other great members and I rebuilt the first three-quarter mile of the 40l trail over a period of two plus years. Prior to our rebuilding, most riders shunned the thrill going up that long side hill from Spanish Creek trailhead. Then on October 27th Wally and Ed Long used five pack horses, loaded 1200 pounds of gravel in two trips and dumped the gravel at a particularly rocky and eroded section of trail. Drains and much more work is needed. Janet Castro's handmade gravel bags worked great. On November 6th Wally and Ed Long rode into the Hell Roaring trail #81 and cleared blow downs past the creek and to the trail junction going about six miles. One tree was cut which was frozen in place and still remains in place. On November 9th I spent some time on the short section of trail in from the hard road to the foot bridge at the Spanish Peak trailhead. If the truth were known most of the time was spent on one rock and it still isn't completely off the trail. Rocks seem to get heavier and more cantankerous every year! Lastly on November 17th I hiked up Spanish Creek trail knowing of two blow downs across the trail. Both were short of the junction to Pioneer Falls trail. I made a clean removal of same. Removed the usual loose rock on the trail and having a heavy hammer and bull point in my pack, I split some rock to save people's shins and called it a day!
