June 5 was our first work day on our adopted trail, the Spanish Creek Trail. Seventeen workers arrived consisting of eleven members and six non-members. Wally divided the people into groups of three to five and each group worked on about a mile of trail up to Mirror Lake trail junction. One group went part

way up the Pioneer Falls trail. General trail maintenance including cleaning and replacing water bars, blow down removal and the usual rock removal. Wally's crew worked too hard and too long. The day was considered a big success.

June 14 Wally and Larry took four pack horses and their load of tools and equipment up South Cottonwood trail to the site of a new foot bridge near Fox Creek Cabin. The work crew completed the bridge and rerouted the trail as required.

June 15 saw Donna McGeein, son Roan, Larry, Wally and Chick back on the Hell Roaring trail.

June 16 Wally, Larry and Chick, with five pack horses, as shown, headed up South Cottonwood trail to pack tools and equipment out from the new bridge and trail site.

June 17 Larry, Wally, Chick, Mike - our young volunteer, Michelle Ratliff - supervisor, with six young people from the Adolescent Resource Center attacked Hell Roaring trail with a vengeance. Our young workers were a willing group and only good things can be said for all of them.

June 22 Wally, Larry and Chick again worked Hell Roaring trail. We had a new volunteer in the person of Ernest Rajola who worked once with us last year and now back again to help this year. With

good soil and the roto-tiller we were able to complete 720 feet of new tread setting an all time world record. Two or three more days should see the end of the Hell Roaring project.

June 27 will be our work day on the upper Spanish Creek trail and after completion of the Hell Roaring trail from the trailhead to the creek it has been suggested that the Garnet Mountain trail be retread from the trail head on up. This will be a good opportunity for the Adolescent Resource Center (ARC) to participate.

The Forest Service has been working on additional gravel bags. It would be advantageous to have three or more sets to achieve a measurable amount of fill for badly eroded trails. Here is my opportunity to mention to BCH members that <u>Janet Castro has made the club two gravel bags</u> that attach to a pack saddle and can be filled while on a horse, transported to the desired location where the bottom of the bag can be opened to deposit the gravel. This has been a great piece of work, Janet. She had spent many hours on the internet getting the necessary information, then making a sample for us before going ahead on the real bags. A lot of energy, time and love went into this project and when the creeks come down enough to expose the sand bars they will be put to use. The club owes her a ton of thanks.

June 24 brought out the ARC with ten people and four so called adults in the form of Wally, Larry, Chick and Ernie. The bad news is that we broke our trail record. The good news is that we established a new 'probably' new world record of 750 feet of new tread...if anybody cares.. Again, good soil and our roto-tiller helped. In-

teresting observation: girls outnumbered boys from the ARC. Don't know what that means!

June 27 was our work day on our adopted trail at Spanish Creek.. Fortunately the David Reed family of four came out and along with the crew of Wally, Larry and I we started up the trail. With two pack horses we were set on cleaning water bars in the upper reaches. We were able to remove some small blow-downs, but had to perform a full out attack on two trees ten to twelve inches in diameter.

Pushing on and hoping to at least see the lakes we were surprised and rebuffed by the snow drifts.. After traveling up to their bellies we felt the horses had had enough, as did riders, therefore we were forced to turn back. We stopped for lunch about 2pm, continued back and arrived at the trail head at 5pm. The water bars will have to wait, but access to the trail was assured for the time being.





June 29 was our Tuesday work day at Hell Roaring. The ADC had 5 crew members and 2 supervisors. Wally, Larry. Earnie and I filled out the total crew. Each day means training the ARC people because they are a different crew each time. With the help of the roto-tiller we completed the trail from trail head to Hell Roaring Creek —a total of 9,000 feet. All equipment was removed and we are now intending to do some repair work on the Garnet Mountain trail.



Our general meeting Thurs, June 24 was so much fun. We were blessed with a sunny and warm evening for a potluck to share with our member friends. We enjoyed Chick's chocolate birthday cake and Rich's ice cream. Heading to the barn after our fill of good eats we had our short and brief meeting then on to

#### Bridger crew trail work: by Kay Tate

6/15—12 riders and 3 pack horses joined Bill Shields to clear and check out the Poker Ride trail #538 south, counterclockwise from the Bridger Bowl parking lot. It was a beautiful day and trees were cut and flung with abandon. On the bottom half of the loop much damage was reported from the recent downpours in the Bridgers.. Several crossings were washed out. On Sunday a crew of 6 returned and rerouted and dug out the washes so horses and the poker ride 4-wheelers could pass in safety.

**6/21**— The Bridger crew was scheduled to clean trail #422 up South Cottonwood to Fox Creek cabin. We knew Chick's crew had been up there 3 times and that nothing

further needed to be done, but after numerous calls to the F.S. to get another trail on the schedule, with no response, 6 of us met at the trailhead for a beautiful day and ride to the cabin. We did work on the new crossing where Ron and his horse "Sport" popped a lariat on a large section of tree that blocked the horse crossing and drug it downstream while the rest of the crew worked on the new trail where it had already washed out.

**6/24** Kay and Ron were unable to attend the Spanish Creek trail clearing day so they took a ride to Dubois Lake today and cleared what they could on the way up and back with my 24" saw, not out of love for the saw work, but because I couldn't find my fishing license. We left some big ones for Sunday in the lake as well as on the trail.

6/27 We rode the poker ride trail with 10 riders on Sunday and good thing too—we found a large tree blocking the trail, and that is after it had been cleared once. Janet and Jose have taken over marking the trail on the Friday before the poker ride and needed to know the way around. Other riders were members who cannot be there on Poker Ride day or have other commitments that don't allow them to ride that day. Bonnie checked out the route for the pop stop people so all is set.

**6/28** For our Monday work Bill Shields was contacted by Brian McNeil and told that the New World/Mystic Lake trail was already clear and would we instead clear the Bangtail Ridge trail beginning at the Brackett Creek Y. It is a beautiful trail with fantastic views of the Bridger Ridge, Ross Peak, Sacajawea, etc. It is primarily a bicycle/hiking trail and therefore dangerous for horseback riders as the bikes come up on you suddenly. A quarter of a mile from Olson Meadows we met a F.S. employee who thought it best that we turn around as a helicopter was in the area making aerial drops for a base camp and a 10 man crew was just up the trail. They are going to do a prescribed burn in the area. Another case of the right hand of the forest service not knowing what the left hand is doing and a misuse of 12 riders and 4 pack horses with chain saws.

#### Eagle Creek campout and trail ride May 29-31 by Kay Tate

Due to inclement weather we drove to Eagle Creek on Sat. and because there was only the three of us, Bonnie, Ron & I, we rode the shortcut to the Black Canyon of the Yellowstone on Sun.. The portion to Crevice Lake was rocky but in good shape and always spectacular. There was a fresh elk kill on the trail but we couldn't tell cause of death (lion, wolf, bear). The ice cave was beautiful at the time of day we passed there. We saw the osprey nest with babies and an adult on the top of a pine nearby. We saw lots of elk antlers and a mountain sheep, lots of deer but no elk or buffalo. After lunch overlooking Crevice Lake we searched and found the Crevice Creek trail (poacher's trail) to the Park boundary north and circled back to camp through Jardine. It was a ride of 20 miles and we wished we had not found the con-

nection because it turned out to climb 2000' in 2 miles. Quite an effort for us and our mounts. Needless to say if there had been more of us we wouldn't have tried this route and definitely never will again. When we got back Bob Steinman and Connie Myslick were in camp having arrived at noon and taken a nice ride around Eagle Creek basin. Monday, Connie and Bob rode around in the basin again and we three rode over to Little Yellowstone and saw the buffalo trap that was used all winter. I sure appreciated the phone calls so I could keep in touch with those considering coming to the camp.
