Trail and Bridge Construction and Trail Maintenance Report for 2005

Our summer trail work started this year on April 27 with cleaning water-bars and ended October 24 with more water-bars. It appeared that the weather was good to us.

The Bridger Trail Crew produced their usual outstanding work with ten days of scheduled trail clearing. They also packed deck planks into the Hell Roaring Creek new bridge site. They also cleared the trail for our annual Poker Ride.

The Adolescent Resource Center supplied us with six to ten young people to assist us. We worked on the Sourdough Summer Trail which was within walking distance. With their help about a mile of trail was restored to specifications.

More trail was restored on the Garnet Mountain Trail, but as yet the five mile trail has not been completed.

The Hell Roaring Creek Bridge has been completed. It is for horses and well worth seeing. It is a 9000 foot ride on restored trail to the bridge. Nine Mile Mule Pack Train, the Bridger Crew and the Mid-week Crew packed materials in and the long pieces were flown in by helicopter. The Forest Service did an outstanding job with engineering, planning and construction.

The Forest Service asked us to pack their work crews in and out of Indian Ridge, Hyalite Lake, Fox Creek Cabin and Buffalo Horn where the Forest Service stayed most of a week and were able to complete an amazing amount of work.

The big club project this year was on our adopted Spanish Creek Trail. The weather finally allowed us to get to the lakes. We spent three days on trail maintenance and preparation. Finally the gravel was delivered and then the Mule Team arrived.

The preparation work related to three or four eroded areas and the mules deposited gravel as needed resulting in a tremendous improvement to a very heavily used trail. Twenty-five people helped load, unload, shovel, rake, pack, etc. This was again an outstanding effort by the club, Forest Service and others. Least I forget, the gravel was donated by a club member.

As per the Forest Service recommendation a Defensive Horsemanship Course was presented to members and those participating in the use of horses in Forest Service work. We had members of the Beartooth BCH who were instrumental in preparing the materials to serve as our instructors. Forty club members participated.

This accounts for the major accomplishments for the year, along with those other projects forgotten or omitted, which produced a very profitable year for the club's accomplishments.

Gallatin Travel Plan Revision Update

The Gallatin National Forest submitted a Notice of Intent in the Federal Register in 2002. In 2003 the forest sent out to the public a scoping document called the "bench mark." In early 2004 the forest presented a draft document with six alternatives for how to manage the thousands of miles of recreational roads and trails on the 1.9 million acre forest. Finally, in early 2005, the Forest Supervisor released the draft EIS with the forest preferred alternative 7.

During the three years the public, local and state governments, non-governmental organizations (NGO's), and the Forest Service have been working on this there have been many meetings to discuss the merits of one alternative or another. Alternative 7 was a well developed alternative that could meet the needs for growing recreational opportunities and is within the capacity of the land.

The Gallatin Forest believes that alternative 7 is pretty close to a final proposal that will come out as the Final EIS and Record of Decision (ROD). It may be called Alternative 7M (M for modified) with some tweaks and will include a large section of "response to comments" and rationale for including the suggestion or why not.

In general, the response to comments will be categorized so that a number of similar comments (for example, not supporting seasonal closures) will be integrated into a comment or concern and responded to by the forest interdisciplinary team (IDT). Their responses will attempt to balance the social and best science available to address the issues.

Right now the forest supervisor and her staff is working hard to address any travel planning areas to add (tweak) the correct mix of recreational opportunities into the final plan and to take any substantive suggestions into consideration. The goal is get the final decision out for public review by late spring or early summer. People will then have 45 days to file an appeal if they cannot live with the decision. If no appeals are received, the forest can begin implementation after another short waiting period.
