Presidents Report April 2009

I want to thank Dr. Shannon Moreaux DVM of Alpine Equine Veterinary for the very interesting slide presentation on equine vaccinations and de-worming. I felt like I should have got a degree in veterinary medicine after the presentation until he told me I had to take the test afterwards. I will be posting a copy of the presentation on the web site as soon as I get it from him. The first vaccinations are due now.

Our April meeting will be a presentation by Dr. Al Flint on equine wound care and management. We will also go over the state convention that was hosted by the Last Chance chapter in Helena over March 27 through March 29th. The convention was a great success and we were handed over all of the gear since we are going to be the host of the state convention next year to be held at the Holiday Inn on March 19th through the 21st. Amy Hathaway has graciously volunteered to chair the convention and she is going to need a lot of your help to get through it.

We had a full delegation of eight that attended the convention. Sherrie White took home a prize for the picture she entered in the photo contest. We have had a club member win a prize in the photo contest from our club for at least the last four conventions. Rich and Jim will present the notes on the convention at our general meeting. The purchase of a personalized license plate for the state organization was dropped along with the proposal to pay for travel expenses for the state directors. The only topic left for discussion was the proposal to support adding additional wilderness to Montana in seven areas that have been targeted for inclusion in the Wilderness Protection Act for some time. It has been 25 years since Montana has had any areas added to wilderness in the state. There was a lot of discussion on whether to add wording into any new legislation adding wilderness that would include the historic use of saddle and pack stock in the wilderness. There was a lot of opposition to adding any wording to the original wilderness act which would allow folks to zero in on the addition and kill the legislation. A number of people opined that the wilderness act was carefully worded and should not be changed. The same people claimed that the congressional record included sufficient language that included historic use of saddle and pack stock in the wilderness to know the addition to add anything.

Janice has the Horse Safety Clinic lined out with speakers, vendors, and a tack sale. Please contact Janice if you can lend a hand at the clinic. We will need people to register the attendees and man the tack sale. We will also need some folks to help setup and take down before and after the event.

Amy Hathaway has offered to take over the duties of the newsletter editor if we can find someone to take over her position as secretary. If you feel you could attend both the board and general meetings and take notes then I would love to hear from you.
