Lance showed me a new set of panniers that is canvas on the outside and lined with a waterproof fabric on the inside so you can throw in elk quarters and not have to worry about blood soaking through the canvas. Our first presenter was Dennis Hodgeson of Fort Dodge Animal Health and had a great presentation on vaccinations and de-worming. Our next speaker was Mike Willson from Nutrena Nutrition, who also presented at the Helena BCHM state convention, offered us some very interesting facts on horse feed. You can find a more detailed write-up later in this newsletter.

We had a wrap-up report of the Sage Creek corral project and for just over \$1,000 we were able to put in 4 24 X 24 corrals complete with gates. We had a great turnout for help with the project and I want to thank Larry and Rich for riding herd on the corrals. Gallatin Back Country Horsemen Board Meeting September 3, 2009

President Dan Marsh called the meeting to order following a brief presentation by Steve Johnston from the Big Sky Community and Gallatin County Advisory Committee (see notes below). In attendance were Jim, Brenda, Dan P., Larry, Marianne Meyer, Stacy Bragg, and Sonja as proxy for Sandy Kypfer.

Minutes of the past board meeting were in the newsletter. Jim motioned to accept them as printed, Stacy seconded; approved.

New Bills: Lee & Dad's IGA for Steaks \$342.24. Jim motioned to pay this bill, Larry seconded; approved.

Stacy will be getting bolts and drill bits for the Sage Creek corral project and wanted to be sure that the club would approve of this purchase. The money for this project has been designated from specific funds and this purchase will definitely be approved.

Correspondence: A reminder notice for Secretary of State filing for the club has been received. Dan will follow up. Proposed Gallatin Forest Plan Cleanup Ammendment will be open for public comment until October 9th. Dan will peruse.

Membership: Marianne has an updated list of all members on Excel.

Issues: Yellow Mule Trail Access

Steve Johnston from Big Sky and a representative of Gallatin County Advisory Committee presented a brief history and current proposal to the Yellow Mule Trails. In 1998 there was a relocation of the existing trail heads. The 1st Yellow Mule access is now at the Ousel Falls trail and access has been lost to the other two except from the top. This occurred due to developments in Big Sky. Steve has suggested that a new trail head be developed for horse access to reroute around the current side hill, and heavily used Ousel Falls trailhead. This project needs support of the Gallatin Preserve Property, which is currently and will remain the secondary route for the Yellowstone Club Community. The developer, Robert Hicks, also needs to approve the easement for this trailhead development. Although there are many steps to pursue, the proposed trailhead will be presented to the County Commissioners on September 10th. Steve asked that GVBCH write a letter in support of the trailhead development. Amy made a motion to support this measure, Dan M. seconded; with one opposing vote from Jim, the motion carried. Jim wanted to be sure to have included in the wording of our letter that the Ousel Falls trail NOT be shut down to horses, just because the new trailhead was being developed, as we do not want to lose any riding rights. This was agreed upon as well as the trailhead being able to accommodate parking for horse trailers.

Gallatin Back Country Horsemen General Meeting Minutes September 17, 2009

President Dan Marsh called the meeting to order following a combined presentation by Lance of Murdoch's, Dennis Hodgeson of Fort Dodge Animal Health, and Mike Willson from Nutrena Nutrition.

Board members and committee chairs in attendance were Dan Marsh, Brenda Kessler, Jim Allbright, Sandy Kypfer, Janice Cartwright, Dan Porter, and Amy Hathaway as well as many fantastic members.

Program: Dennis Hodgeson reviewed West Nile vaccination, following up with worming information every horse owner should know.

2009 resulted with six Montana horses having been confirmed to have been infected with West Nile residing in Lake, Flathead and Sanders Counties. Fort Dodge now only recommends one annual booster for this area in the spring 4-5 weeks prior to heavy mosquito time. The earliest this virus has been cited in Montana is July 25th, due to the fact that the early April-May mosquitoes do not transmit West Nile.

For a quick overview of the worming information:

Primary GI Parasites in the Horse are:

- Large Strongyles "Blood Worms"
- Ascarids "Round Worms"—parasite of young horses less than 2 years.
- Cyathastone "small strongyles"
- Bots—actually a larval fly, not a worm
- Pinworms "Butt-itch"
- Tapeworm—are seeing more in Montana

Ones to be concerned about today are the Small Stongyles and the Tapeworm. The Small Strongyles will burrow into the horse to emerge in the spring. The tapeworms should be wormed for with the Fall worming. Dennis suggests using Qwest Plus or Ivermectin Plus products in Late Fall to eliminate tapeworm infestations for the following year.

A new, more individualized method of worming is now being suggested to prevent resistance to existing drugs. It has been suggested to do fecal counts on individual horses at specific times of the year to see the infestation of specific animals. Treat the high counts up to four times a year, but leave the lower fecal egg count horses to lesser wormings. This will maintain refugia, a parasite population that is still susceptible to the existing de-worming products.

Gallatin Back Country Horsemen General Meeting Minutes (continued) September 17, 2009

Program *con't* Mike Willson of Nutrena Nutrition offered feeding tips to prevent colic and choke during pack trips or hunting season. Nutrena offers a number of excellent complete feeds that can be purchased at Murdoch's that are Montana Weed Free Certified. Mike suggests converting to a different feed slowly—not overnight. Also, my favorite tip, to slow your horses down while eating pelleted food, add a handful of round rocks to the feed bucket for them to lip around.

Minutes: Jim made a motion to accept minutes as appeared in the Newsletter; Janice seconded, carried.

New Bills: Dan Marsh had a bill for registering BCH with the Montana Secretary of State; Stacy Bragg presented a receipt for screws and bits for the amount of \$205, rails came to \$805.54. Jim made a motion to pay the SOS bill, Janice seconded, carried. The rails, bits and screws were previously approved and designated for purchase.

Issues: The Yellow Mule trail access (see notes from Board Meeting) was to be presented to the County Commissioners in September, but has been postponed until October. Jim Allbright has fears that Big Sky is trying to enforce "no horses" on the Ousel Falls trail.

The last corral project was so successful that we should start looking for another. A suggestion was made to do corrals at Spanish Peaks.

Membership: The current member registry has 73 entries.

Newsletter: Margaret has been doing a wonderful job.

Trail Crews: Still heading out there, but call before you go.

Program: Janice always appreciates your suggestions.

Old Business:

 The Steak Ride was a fantastic success, feedback was positive, money balanced in the positive and approximately 50 riders had a great day. Thank you, Dan Porter.

 The Sage Creek Corral project has been successfully completed. Approximately 25 people showed up, and the project was completed with amazing efficiency.
