The Montana Conservation Corps has asked the club to hold a training stock use training class for its volunteers. The board felt that this was a good idea and suggested that we contact them and discuss what the class should cover and when we should hold it.

#### Trail Crews

The Copper City job was cancelled because of the heavy snow fall. The cleanup will be done next spring. It will be the clubs number one priority.

Rich Inman suggested that we should ask the Forest Service to give the club more input on where we should concentrate our efforts in improving trails in the Gallatin national Forest.

One interesting note was that the miniature horse can be taught to recognize seizures before they start. It was a very interesting look at a "horse" in a different setting.
