## MINUTES OF LAST BOARD MEETING

Sue Geske made a motion to approve the minutes from the last meeting, Chris Nygren seconded, and the motion passed.

## FINANCE REPORT

Sharon Fraser reported two new bills: The first was a general liability insurance policy bill. Chris Nygren mentioned that he has checked on prices, and the quote received is a good one. Rich Inman submitted a printing bill for horse etiquette cards, as requested at the last meeting. A motion to pay the bills was made by Tamara Erickson, was seconded by Sharon Fraser, and the motion passed.

#### Correspondence

Sharon reported the club received two cards from the Forest Service regarding a resolution to oppose the sale of Federal Lands, and also a Bitterroot BCH Chapter newsletter.

## STANDING COMMITTEE REPORTS

No standing committee reports were made due to a short meeting so that the board could participate with the Wild Game Feed.

## **OLD BUSINESS**

Errors and Omissions Insurance for Officers & Board: Chris Nygren reported that the quotes submitted last month are the best set of quotes available. A discussion ensued about whether or not the board should obtain E&O insurance. Some questions were asked and answered, including the differences between the types of policies quoted, and which would be most suitable. In summary, E&O insurance will cover board members from personal liability in the event that GVBCH is sued, and board members are attached in the lawsuit. Carl Blaskovich made a motion to obtain insurance at a \$545 premium annually, Harry Huntsinger seconded, and the motion passed.

Annual Report to Secretary of State: Sharon Fraser submitted the annual report to the Secretary of State, and e-filed taxes to the IRS.

RAC Grant: Henry Glenn has been in touch with the Forest Service. There is a possibility of obtaining money for a new RAC Grant, but someone needs to head it up. Henry is willing to head it up, but needs to know which projects

to apply for. He would like support from the board in choosing a project. Several ideas were discussed but no project was decided upon, and it was decided that an RAC Grant would possibly not be applied for this year.

RTP moneys from last July: Rich Inman stated that all RTP Grant money payouts, including reimbursements to the treasury, have been made.

Safety training: Rich Inman stated that Defensive Horsemanship Safety Training, required for all volunteers clearing trails for the Forest Service, has been scheduled and calendars should be marked. The training will be divided into two segments. The first segment of the Defensive Horsemanship Training will be provided with a video presentation at the May 19th General Membership meeting during the program. The second segment will be held on Saturday May 21st at the fairgrounds. Members may or may not be required to bring their horses on Saturday, which will be determined at a later date.

#### **New Business**

Identify delegates to State Convention (Apr. 1, 2, 3): Eight delegates are needed for the State Convention, and a list of interested members was compiled. Lawrence VanDyke made a motion to approve the eight delegates submitted, Sue Geske seconded the motion, and the motion passed.

\$50 Auction item for State Convention: Rich Inman agreed to provide an auction item.

2016 Poker Ride: Tamara Erickson asked for volunteers to form the 2016 Poker Ride Committee. Sue Geske, Carmen Matzick, Rich Inman, Dan Marsh, Harry Huntsinger, Henry Glenn, Mike Haugan, Beth Merrick, and Rich Inman volunteered to serve on the committee. The first meeting will be held in March, and results will be reported at the March General Meeting.

A motion was made by Tamara Erickson to adjourn the meeting, Sue Geske seconded the motion, and the meeting was adjourned.

Members may or may not be required to bring their stock to the Saturday training, which will be determined and announced at a later date. The location has not yet been determined, and will also be announced at a later date. This training will be a joint venture between 4-H equine club participants and their parents, GVBCH, Forest Service employees, and the Gallatin Valley Saddle and Harness Club. The video portion can also be viewed online.

Brian asked if a biker/horse safety clinic is planned this year. Several people agreed that it was an effective and worthwhile training. Janice agreed to take a look at the calendar to see if it is possible to schedule another training date involving horses.



#### MARCH GENERAL MEETING PRORAM



Hannah Jaicks is an interdisciplinary scientist with an interest in developing stronger avenues of communication and inclusion amongst the public, decision makers and scientists about human-wildlife conflicts and ecosystem management.

Since age 15, Hannah has studied and worked with over 30 species of exotic animals around the world, including: hyenas, bats, giraffes, penguins, warthogs, orangutans, gorillas, and many others. Her work and research are born out of her broader and lifelong interest in understanding how our science and policy measures have a critical responsibility when it comes to mediating coexistence between people and animals in shared environments.

Hannah received her Ph.D. in Environmental Psychology from the Graduate Center of the City University of New York, and she received her B.A. in Biology and Psychology from Swarthmore College. A Bozeman resident, her research has taken her through the Greater Yellowstone Ecosystem (GYE) for the past four years, where she continues to pursue efforts that empower and enable rural agricultural livelihoods to successfully persist alongside healthy and abundant wildlife populations. In this context, she views herself as a broker attempting to integrate the needs of people and wildlife communities alike, and she endeavors to transform stakeholders' opportunities to meaningfully

participate in the management of their special places--the places the make the GYE what it is. She is grateful for the opportunity to speak to the Gallatin Valley Backcountry Horsemen and hopes to have it be an open dialogue to learn from everyone in the community.
